History

- Created in May 2006 to improve coordination of foodborne outbreak investigations between CFIA and MOHLTC
- By March 2007, OMAFRA, PHAC, CIPHI and ASPHIO had joined WG
- HC and OAHPP joined in Feb. of 2009
- MNR recently joined in early 2010

- Strengthen relationships/ build bridges

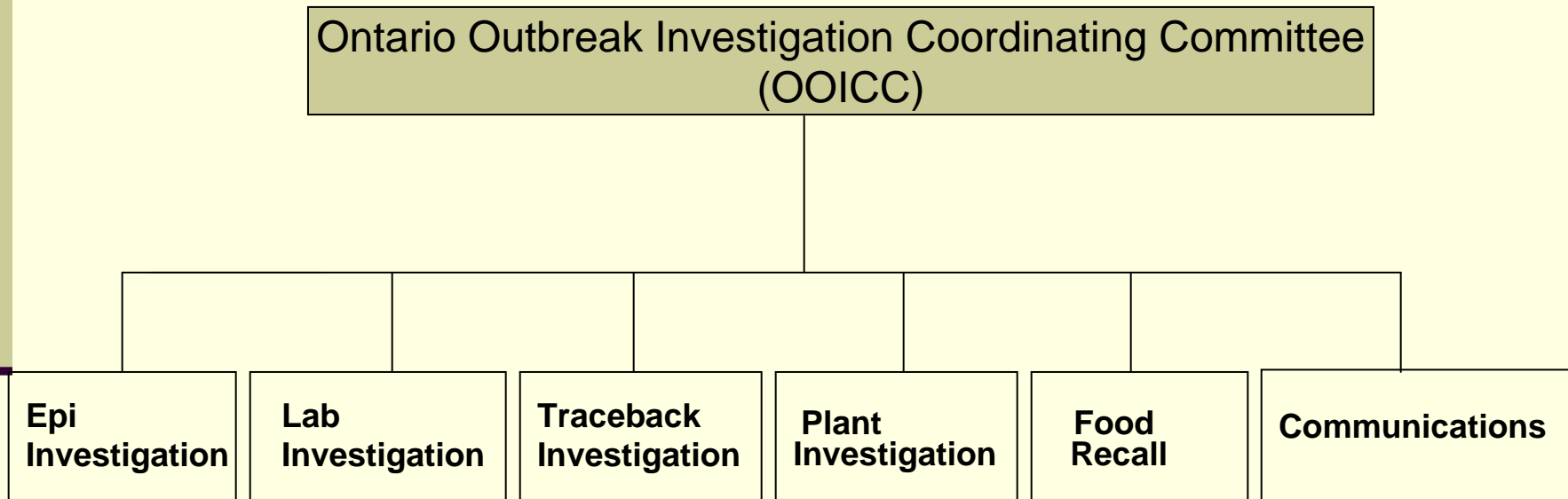
- Challenges

Objectives

- Clarify roles and responsibilities of each agency in a foodborne outbreak/food recall
- Improve the coordination of activities, where activities overlap between agencies
- Review foodborne outbreak/food recall events for the purposes of improving the handling of future events
- Communicate the findings from this WG to the respective agencies and other stakeholders where appropriate
