

## ADP-Registered Vendors of Ocular Prostheses

This document includes questions and answers to assist registered ocular prostheses vendors understand the changes being made to the pricing for ocular prostheses and related services under the Assistive Devices Program (ADP).

### Q1 What are the new prices for ocular prostheses and related services?

A1 Please refer to the following table for a full list of changes (ADP will also publish a new product manual for the device category) effective June 7, 2021. All devices and services in this category are being updated:

**Q2 What is the effective date for the new prices for ocular prostheses and related services?**

**A2** The new pricing schedule takes effect on June 7, 2021.

**Q3 Has the ADP made any changes to who is eligible to receive 100% funding for ocular prostheses and related supplies?**

**A3** No, the ADP has not made any changes to the current ADP eligibility criteria.

Ontarians who meet the eligibility criteria for 100% funding will continue to receive 100% of the new device price for funded ocular prostheses and related supplies.

**Q4 Has the ADP made any other changes to the policies and procedures for ocular prostheses?**

**A4** The ADP has not made any other changes to the policies and procedures for ocular prostheses.

**Q5 Are there any changes to the policies concerning how the ADP-registered vendor invoices the ADP for ocular prostheses?**

**A5** No, the ADP has not made any changes to the current policies or procedures for invoicing the ADP for ocular prostheses.

The new prices will take effect June 7, 2021. Therefore, any applications with a delivery date for devices of June 7, 2021 or after will be subject to the new prices.

When an application is submitted and approved for an Ocular Protheses, a maximum amount may be automatically pre-allocated for related devices and procedures for the five (5) year designated funding period, referred to as a 'Funding Package'. Existing applications approved with funding packages for services and procedures may be billed at the new pricing as of June 7, 2021.

**Q6 What information was used to arrive at the new price?**

**A6** In order to ensure that registered vendors are fairly compensated for providing these custom devices and related supplies, the government is implementing a price change for these devices, which will result in slightly higher co-payment costs for the ministry and patients, starting June 7, 2021.

Price changes were informed by extensive market and trend analysis, information found in other jurisdictions, expert advice and the size of Ontario and the ongoing service needs of clients.

Increasing prices ensures that vendors will continue to operate in Ontario, providing these valuable services to clients requiring ocular prostheses.

**Q7 Will ADP be communicating the price changes to existing clients?**

A7. No. Vendors will be responsible for informing individuals interested in purchasing ocular prostheses about the ADP approved prices for any new devices or services/procedures required.

**Q8. When will vendors of ocular prostheses be able to submit applications via ADP's secure portal?**

A8. The Ocular Prostheses device category will transition to electronic claim submission on May 3, 2021.
