Physicians are reminded that their application for Reimbursement of Malpractice Fees for the year 2005, (Option C only), must be <u>received</u> by the Ministry of Health and Long-Term Care no later than <u>June 30, 2006</u>.

You must return the completed application with your 2005 Canadian Medical Protective Association (CMPA) Acknowledgement to the Ministry of Health and Long-Term Care.

If your malpractice liability fees are paid to an organization other than the CMPA, a receipt demonstrating proof of payment for the year 2005 must be enclosed.
